# Immediate Jeopardy Defined

- Immediate Jeopardy is:
- A situation in which **immediate corrective action** is necessary because the provider's **noncompliance** with one or more requirements of participation or conditions of participation has **caused, or is likely to cause, serious injury, harm, impairment, or death** to an individual receiving care in a facility.

# Immediate Jeopardy Components

- **Noncompliance:** An entity has failed to meet one or more federal health, safety, and/or quality regulations; AND
- **Serious Adverse Outcome or Likely Serious Adverse Outcome:** As a result of the identified noncompliance, serious injury, serious harm, serious impairment or death has occurred, is occurring, or is likely to occur to one or more identified recipients at risk; AND
- **Need for Immediate Action:** The noncompliance creates a need for immediate corrective action by the provider/supplier to prevent serious injury, serious harm, serious impairment or death from occurring or recurring.

# Immediate Jeopardy Template

- For every tag cited at an IJ level, an individual IJ template is needed.
- The IJ template is an unofficial document that provides key information regarding the non-compliance and how it meets the IJ criteria.
- Allows for clear communication of the noncompliance, the impact or likely impact to the recipient of care, and the need to take immediate corrective action to prevent the occurrence or recurrence of serious injury, harm, impairment, or death.

# Removal Plan

- Entity's response to address the immediacy of the non-compliance.
- Guideline:
  - Facility letterhead or Facility Name/Address
  - Tag # associated with the IJ
  - Indicate the deficient practice
  - State how the facility will correct the specific findings:
    - What immediate measure(s) will be put into place to remove harm or prevent serious harm from occurring/reoccurring.
    - Staff education/re-education. Who will educate? What education will be received by staff? (i.e., Policy and Procedure/Facility chosen nationally followed standards).
  - Completion Date: date by which the entity asserts likelihood of serious harm to any recipient no longer exists (i.e., When action (interventions) and education will be completed).
  - On bottom of form: Name/Title/Signature/Date & Time

# Removal Plan Example

IJ Template: Reflects on 1/31/24, the facility failed to ensure that multi-dose vials of medications that are accessed in the immediate patient care area, are discarded immediately after a single patient use. Tag 240-Infection Control-Safe Injection Practice Multi-Dose Vials.

Removal Plan: On facility letterhead or Facility Name/Address include the following:

- During a Federal complaint survey, the following Immediate Jeopardy related to infection control was identified:
- **IJ #1** (if multiple) Tag 240 – Infection Control – Safe Injection Practice Multi-Dose Vials
- **Deficient Practice:** The facility failed to ensure that multi-dose vials of medications that are accessed in the immediate patient care area, are discarded immediately after a single patient use.
- Identify all actions (i.e., interventions, education, etc.) the facility will take to immediately address the noncompliance that has resulted in an immediate jeopardy by detailing how the entity will keep recipients safe and free from harm caused by noncompliance.
  - All opened multidose vials were immediately discarded
  - Safe injection policy and procedure was reviewed to ensure multidose vials are discussed
  - Anesthesiologist and nurses were provided education to include review of the policy and procedure that indicates multidose vials are not to be accessed in patient care areas.
- Completion Date: 1/31/24

# After an Immediate Jeopardy

- Survey Team must verify full implementation of the removal plan while on-site
- 2567 (official survey report) is generated and sent to facility (non-deemed) to CMS (deemed)
  - Condition statement that includes IJ information included in the report with the specifics of removal plan and when the IJ was removed.
- Plan of Correction is required by facility within 10 calendar days
  - Completion dates
- Condition-level survey revisit required
